What is this product?

Type: Shares of a Sub-Fund of CPR Invest, an Undertaking for Collective Investments in Transferable Securities (UCITS), established as a SICAV.

Term: This Sub-Fund matures on 31/12/2029. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

Objectives: The investment objective is to achieve income and capital appreciation over the recommended holding period (at least 5 years) by building a "buy and watch" diversified credit portfolio, which contributes to the European recovery and resilience, while integrating Environmental, Social and Governance (E, S, and G - or, when taken together, ESG) criteria in the investment process.

On 27 June 2027 (i.e., thirty-six months following the end of the Initial Subscription Period), the Compartment will be closed to further subscriptions.

This Compartment has been launched on 22 July 2024 and will mature on 31 December 2029 (the "Maturity Date").

To achieve this, the Compartment aims to select securities of companies active in economic sectors that have a direct or indirect link with Europe's resilience and/or that contribute to Europe's economic autonomy and development such as Food, Healthcare, Industrials, Energy, Digital, Defense... The Management Company integrates an ESG approach by excluding companies based on the following :

the lowest Amundi overall ESG scores (i.e., F and G on a scale from A to G);

ESG controversies deemed to be severe;

The Compartment seeks to achieve an ESG score of its portfolio greater than that of 50% ICE BofA 3-5 Year Euro Corporate Index + 50% ICE BofA BB-B Euro High Yield Constrained Index.

The Compartment is mainly invested in Euro and US dollar-denominated bonds (including green bonds) issued by public (government, supranational, local/international public bodies) and private issuers incorporated, headquartered or having their principal business activities in the European Economic Area (EEA) as well as in the UK and Switzerland.

The Compartment invests at least 40% in securities rated "Investment Grade".

The Compartment can be invested up to 60% of its assets in securities rated "Speculative Grade" at the time of their acquisition.

The Compartment's investments may include, but are not limited to, subordinated bonds, senior bonds, preferred securities and perpetual bonds (within a limit of 25% of its assets for perpetual bonds). The Sub-Fund may invest up to 30% in corporate hybrid and subordinated bonds.

The Compartment may also invest up to 5% of its assets in emerging markets, belonging to the EEA.

The Compartment may invest up to 25% of its assets in callable bonds maturing after the Maturity Date provided they have a first call date before the Compartment's Maturity Date.

Derivative instruments will be used for hedging, arbitrage, exposure purposes and/or efficient portfolio management. The Compartment is actively managed and is not managed in reference to a benchmark.

The Compartment is a financial product that promotes ESG characteristics pursuant to Article 8 of the Disclosure Regulation.

Intended Retail Investor: This product is intended for investors, with a basic knowledge of and no or limited experience of investing in funds seeking to increase the value of their investment over the recommended holding period with the ability to bear losses up to the amount invested.

Redemption and Dealing: Shares may be sold (redeemed) as stated in the prospectus at the respective dealing price (net asset value). Further details are provided in the CPR Invest prospectus.

Distribution Policy: As this is a non-distributing share class, investment income is reinvested.

What are the risks and what could I get in return?

RISK INDICATOR



The risk indicator assumes you keep the product until 31/12/2029. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movement in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

COSTS OVER TIME

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, and how long you hold the product. How long should I hold it and can I take money out early?

Recommended holding period: 5 years, which corresponds to the maturity of the product. The Sub-Fund is designed to be held until its Maturity Date; you should be prepared to stay invested until maturity. If you sell prior to the Maturity Date of the Sub-Fund an exit fee may be payable and the performance or risk of your investment may be negatively impacted.
